Steering Committee of the Academy of Justice,

Pursuant to Article 10, paragraph 1, sub-paragraph 1.4, and Article 25 paragraph 3 of the Law no. 05/L-095 on the Academy of Justice, Article 3 paragraph 1, sub-paragraph 1.6 of the Regulation no. 02/2023 on Amending and Supplementing the Regulation no. 02/20217 on the Work of the AJ Steering Committee, and Article 41 paragraphs 1 and 3 of the Law no. 05/L-31 on the General Administrative Procedure, on September 11 2025, issues the following:

DECISION

1. Approving the request of the Chief prosecutor of the Basic Prosecution in Gjakova no. 145/2025 dated 11.08.2025 addressed to the Kosovo Prosecutorial Council and the Academy of Justice to amend and supplement the Decision for proposal of mentors for the newly appointed prosecutors.
2. Supplementing and amending point 2 of the Decision of the Academy of Justice's Steering Committee no. 01/16/2025 that assigns the mentors of the Generation 11 of the newly appointed prosecutors, so that the mentor Mr. Sadri Alija is substituted by prosecutor Mr. Mr. Qazim Kuqi.
3. The mentors are obliged to perform their duties and responsibilities in compliance with the applicable legal provisions.
4. Decision enters into force upon its signature.

Reasoning

The Kosovo Prosecutorial Council, according to the request no. KPK/07/2025 dated 08 January 2025, has proposed for appointment to the Academy of Justice the list of mentors for prosecutors with the initial mandate (generation XI).

The AJ Steering Committee has approved the proposed list of mentors through a circular procedure on 10 January 2025, part of which was also the prosecutor Mr. Sadri Alija as mentor assigned to the Basic Prosecution in Gjakova.

On the occasion of the transfer of Prosecutor Sadri Alija from the Basic Prosecutor's Office of Gjakova to the Basic Prosecutor's Office of Pristina, the Basic Prosecutor's Office of Gjakova, according to request A.nr.145/2025 dated August 11, 2025, has proposed that prosecutor Qazim Kuqi be appointed as the mentor of prosecutor Vlora Rraci.

This amendment to the decision was made to ensure the continuity of the practical training process for prosecutors with the initial mandate.
