# MEMORANDUM OF UNDERSTANDING between

THE MINISTRY OF JUSTICE;

**ACADEMY OF JUSTICE** 

and

KOSOVO CHAMBER OF MEDIATORS

#### Article 1 Purpose

This Memorandum of Understanding aims to set forth the duties and responsibilities of the signatory parties in provision of continuous (refresher) training for the licensed mediators in the Republic of Kosovo, with the purpose of equipping them with the advanced knowledge for carrying out the mediation in compliance with the applicable legislation.

### Article 2 Duties and responsibilities of the Ministry of Justice

- 1. Duties and responsibilities of the Ministry of Justice are the following:
  - 1.1 Allocating funds to the Academy of Justice for compensation of national trainers certified by the Academy of Justice and the FMCS team according to the fee for compensation of trainers set forth with the Decision of the Academy of Justice's Managing Board and in compliance with the Regulation on Trainers and Mentors;
  - 1.2 Equipping the mediators with certificate of successful completion of the refreshing trainings in cooperation with the Academy of Justice;
  - 1.3 Appointing the contact point for coordinating joint activities of the signatory parties of this Memorandum.

### Article 3 Duties and responsibilities of the Academy of Justice

- 1. Duties and responsibilities of the Academy of Justice are the following:
  - 1.1 Preparing the training program in cooperation with the Kosovo Chamber of Mediators;
  - 1.2 Selection of national trainers;
  - 1.3 Ensuring technical and administrative support for trainers and mediators;
  - 1.4 Appointing the contact point for coordinating activities of the joint activities of signatory parties of this Memorandum.

## Article 4 Duties and responsibilities of the Kosovo Chamber of Mediators

- 1. Duties and responsibilities of the Kosovo Chamber of Mediators are the following:
  - 1.1 Preparing the list of mediators that need to undertake the refreshing trainings according to the applicable law;
  - 1.2 Cooperate with the Academy of Justice for preparing the training program based on the needs for professional development of the mediators;
  - 1.3 Appointing the contact point for coordinating joint activities of the signatory parties of this memorandum.

### Article 5 Venue and duration of provided trainings

The refreshing trainings for the licensed mediators in the Republic of Kosovo will be held in regions within the Republic of Kosovo as evaluated by the Academy of Justice and the FMCS team, in duration of three days.

#### Article 6 Dispute resolution

Any possible ambiguity or dispute between the parties regarding the duties and responsibilities arising from this agreement shall be resolved by the parties amicably.

#### Article 7 Entrance into force

This Agreement enters into force on the day of signature by the parties and is valid until completion of the Mediator Training Program of 2024.
