REGULATION (KJA) NO. 01/2025 ON AMENDING AND SUPPLEMENTING THE REGULATION NO. 05/2023 ON INTERNAL ORGANIZATION AND SYSTEMATIZATION OF WORKING PLACES IN THE JUSTICE ACADEMY

#### Steering Committee of the Kosovo Justice Academy,

Pursuant to Article 10, paragraph 1, sub-paragraph 1.1, Article 17, paragraph 1, sub-paragraph 1.10, and Article 23, paragraph 1 of the Law No. 05/L-095 on the Justice Academy, in its meeting held on 29 January 2025, Approves the following:

#### REGULATION (KJA) NO. 01/2025 ON AMENDING AND SUPPLEMENTING THE REGULATION NO. 05/2023 ON INTERNAL ORGANIZATION AND SYSTEMATIZATION OF WORKING PLACES IN THE JUSTICE ACADEMY

#### Article 1 Purpose

This Regulation aims to amend and supplement Regulation (KJA) No. 05/2023 on Internal Organization and Systematization of Working Places at the Justice Academy (hereinafter referred to as the Basic Regulation).

#### Article 2

Article 20 of the Basic Regulation is amended as below:

Throughout the text of Article 20, including its title "Senior Personnel Officer" is replaced with the name "Senior Human Resources Officer".

#### Article 3

Article 21of the Basic regulation is amended as below:

Throughout the text of Article 21, including its title named "Certification Officer", is replaced with the name "Senior Certification Officer".

#### Article 4

- 1. Names of positions (working places) in the Annex 1 of the Organizational Chart of the Basic Regulation, Certification Officer and the Senior Personnel Officer, change as below:
  - 1.1. Certification Officer changes to Senior Certification Officer;
  - 1.2. Senior Personnel Officer changes to Senior Human Resources Officer.
