Based on the Article 10 paragraph 1, subparagraph 1.7 and Article 11 paragraph 4 of the Law No. 05/L-095 on the Academy of Justice, the Managing Board of the Academy of Justice in the fourth meeting of the first composition, held on 18 July 2017, took the following:

### DECISION

1. Annulment of the recruitment process of the Executive Director of Academy of Justice Reference No. 01/01/ZD-AD, announced on 09 June 2017.
2. The Decision enters into force upon its approval by Managing Board.

### Reasoning

Managing Board of the Academy of Justice on 1 June 2017 took the Decision No. 01/145/2017, for initiating the recruitment procedure for the Executive Director of the Academy of Justice. This decision authorizes the administration of the Academy of Justice to announce the public competition according to the legislation in force, whilst instructs the Selection Committee of the Executive Director of the Academy of Justice and the administration of the Academy to develop recruitment procedures.

Public competition was announced on 09 June 2017 and was opened until 23 June 2017. Pursuant to Article 10, paragraph 4 of the Regulation no. 01/2017 on the Procedure for Selection and Dismissal of the Executive Director of the Academy of Justice, the Administration of the Academy on 24 June 2017 published the notice of extension of the deadline for another 7 days due to pending applications for gender and ethnic balancing. After this deadline, the public competition was closed on 30 June 2017.

Managing Board at the meeting held on 18 July 2017 while discussing the recruitment process of the Executive Director of the Academy of Justice and found that during the announcement of the announcement were conducted violations of legal provisions in force due to calculation of the deadlines, by calculation of 15 days of the announcement, respectively 7 days extension of the competition and the date of the public announcement, was done a violation of Article 81 paragraph 2 of the Law no. 05 / L-031 on the General Administrative Procedure "*When the deadline is determined on a day, its calculation shall exclude the day of the event from which the deadline begins to run.*"

Managing Board of the Academy of Justice found that these actions are in contravention with the legal provisions in force and have prevented the fulfillment of the contest purpose, which is to give the opportunity of all interested candidates to apply, to submit their documents within the deadline set by law, therefore, was decided based on the enacting clause of this decision.



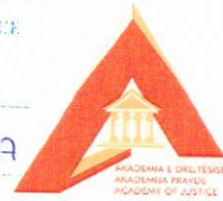
