Managing Board of the Academy of Justice,

Pursuant to Article 10, paragraph 2 of the Law no. 05/L-095 on the Academy of Justice, Article 6 paragraph 1, sub-paragraph 1.10 of the Regulation No. 02/2023 for amending and supplementing the Regulation No. 02/2017 on the Work of the Academy's Managing Board, and Article 20 paragraph 2 of the Regulation No. 03/2017 on the Initial Training, in its meeting held in June 03 2024, based on recommendation of the Committee for Reviewing the Complaints on the final ITP test, unanimously reached the following:

DECISION

1. **Rejecting** the complaint of Ms. Iliriana Haziri Kryeziu (newly appointed prosecutor, generation X), number 220 dated May 10 2024, about evaluation of the final test for the newly appointed prosecutors of generation X, organized by the Academy of Justice during the 24-26 April 2024.

2. Decision enters into force upon its approval.

Reasoning

On April 24-26, 2024, the Academy of Justice conducted the final test for newly appointed prosecutors (generation X), in 5 training modules, in accordance with Regulation No. 03/2017 for Initial Training. In this case, the prosecutor Mrs. Iliriana Haziri Kryeziu, after the publication of the final results, filed a complaint against the results of the final test, in the modules of the Criminal Code, Criminal Procedure Code, Legal Order and Personal and Interdisciplinary Skills.

The Committee for reviewing the complaints of the final test in the ITP, established by the Managing Board of the Academy of Justice, at the meeting held on May 21, 2024, reviewed the complaint of the prosecutor in question by completely revising the test in the modules in which the prosecutor expressed dissatisfaction in evaluation.

After the review of the test and the evaluation by all the members of the Committee for the evaluation of complaints, the Committee unanimously evaluated the complaint as unfounded,

supporting the evaluation of the preliminary Commission who compiled the test questions and evaluated the candidates, considered that the evaluation was correct, professional and without technical errors.

Therefore, the Managing Board approving the Committee's recommendations, unanimously approves the recommendation as in the enacting clause of this decision.
