Managing Board of the Academy of Justice, based on Article 10 paragraph 1, sub-paragraph 1.4, and Article 25 paragraph 3 of the Law No. 05/L-095 on the Academy of Justice, Article 14 of Regulation 08/2017 on Trainers and Mentors of the Academy of Justice, and Article 2 of the Regulation 08/2017 for amendment and complementation of the Regulation No. 06/2017 on the Trainers and Mentors of the Academy of Justice, in its fourteenth meeting of the first constituency that took place on December 26 2018, issues the following:

DECISION

- 1. Approving proposal of the Kosovo Judicial Council for the mentors of the criminal law area that will be engaged as mentors for the newly appointed judges in the Initial Training program, as outlined below:
 - 1.1 Mentors of the recently integrated judges in Basic Court of Mitrovica are:
 - 1.1.1 Tomislav Petrović, Judge of the Basic Court in Mitrovica, mentor of the judge Veljko Vučetić;
 - 1.1.2 Radoslav Marković, Judge of the Basic Court in Mitrovica, mentor of the judge Slađan Ribarić;
 - 1.1.3 Lidija Vučurović, Judge of the Basic Court in Mitrovica, mentor of the judge Slađana Šćepanović;
 - 1.1.4 Branka Semenov, Judge of the Basic Court in Mitrovica, mentor of the judge Vesna Milić.
 - 1.2 Mentor of the recently integrated judge in the Basic Court of Prishtina is:
 - 1.2.1 Agim Kuqi, Judge in the Basic Court of Prishtina, mentor of the judge Ljiljana Maksimović.

- 2. Mandate of the appointed mentors ends upon completion of the Initial Training Program for the recently integrated judges and in compliance with provisions of the Law on the Academy of Justice 05/L-095 and Regulation No. 06/2017 on Trainers and Mentors of the Academy of Justice.
- 3. Mentors are engaged for implementing the practical training program in the criminal law area for the remaining part of the Initial Training.

Managing Board of the Academy of Justice, pursuant to Article 11 paragraph 4 of the Law No. 05/L-095 on the Academy of Justice, and Article 18 of the Regulation No. 02/2017 on the Work of the Managing Board of the Academy of Justice, in its fourteenth meeting of the first constituency held on December 26th 2018, issues the following:

DECISON

- 1. Approving recommendation of the Kosovo Judicial Council numbered no.1/555 dated 05.12.2018, for continuation of the Initial Training for the judges Mrs. Filloreta Lekiqi and Mrs. Elvira Emini, who could not complete the Initial Training due to objective reasons.
- 2. The judges, from item 1 of this decision, will continue the remaining part of the initial training by joining the next generation of the newly appointed judges who will commence the Initial Training after their decree.
- 3. Executive Director of the Academy of Justice is guided to adjust the program of the Initial Training for the upcoming generation of judges, with the remaining part of the training of the judges who could not complete the Initial Training.
- 4. Decision enters into force on the day of its signature.

Reasoning

Academy of Justice has commenced the initial training for the newly appointed judges – sixth generation on 29.09.2017. Mrs. Filloreta Lekiqi and Mrs. Elvira Emini were part of this training that lasts 12 months.

As per the decision of the Kosovo Judicial Council No. 03/345 dated 11.05.2018, Mrs Elvira Emini is approved her maternity leave starting from 02/05/2018, for which reason she stopped attending the Initial Training. Whereas Mrs. Filloreta Lekiqi has stopped the Initial Training on 23/03/2018 because she entered into maternity leave as per the decision f KJC number no. 102/2018 dated 30.03.2018.

Kosovo Judicial Council on 30 November 2018, issued the Recommendation No. 01/555, recommending to the Academy of Justice to find the possibility for the judges who were not able to completely attend the Initial Training due to objective reasons, to continue the remaining part of the training and undertake the assessment process based on the results demonstrated during the Initial Training.

Managing Board of the Academy of Justice, after reviewing the Kosovo Judicial Council's recommendation and after estimating the high financial cost for organization of the Initial Training only for the two judges who could not complete the Initial Training for objective reasons, brought a decision that the judges, Mrs. Filloreta Lekiqi and Mrs. Elvira Emini join the judges of the seventh generation who will commence their training after decree by the President of the Republic of Kosovo. Organization of the Initial Training shall adjust, to the remaining part of the training for Mrs. Lekiqi and Mrs. Emini, in order to shorten the time of their waiting for completion of the training.

Based on the Recommendation of the Judicial Council and applicable legal provisions, it is decided as in the provisions of this decision.
